- Commission on the Grant-in-Aid bill and shall be disbursed to and credited to grantee as above through Demand Draft. 3 The grant is subject to the adjustment on the basis of Utilisation Certificate in the prescribed proforma submitted by the University/College/Institution.
- The University/College shall maintain proper accounts of the expenditure out of the grant which shall be utilised only on approved items of expenditure

The Utilisation Certificate to the effect that the grant has been utilised for the purpose for which it has been sanctioned shall 5 be furnished to the University Grants Commission as early as possible after the closing of the current financial year. 6

The assets acquired wholly or substantially out of the University Grants Commission's grant shall not be disposed or encumbered or utilised for the purpose other than those for which the grant was given, without proper sanction of the University Grants Commission. 7

A register of assets acquired, wholly or substantially out of the grant shall be maintained by the University/College in the

The grantee institution shall ensure the utilization of grant-in-aid for which it is being sanctioned/paid. In case of nonutilization/part utilization, the simple interest @10% per annum as amended from time to time on unutilized amount from the date of drawal to the date of refund as per provisions contained in General Financial Rules of Govt. of India will be charged. 9

The University/College shall follow strictly all the instructions issued by the Government of India from time to time with regard to reservation of posts to Scheduled Castes and Scheduled Tribes.
